President's Message



Dear Friends,

SLI and Festival of Trees proudly celebrated the 40th anniversary of the Festival of Trees, the signature fundraising event for SLI. The Festival of Trees was started when SLI needed to raise \$16,000 to cover a budget shortfall. The event was organized and spear headed by Maggie Beers along with other volunteers and board members. That year, \$16,000 was raised to cover the needed funds. Since that time, the Festival of Trees has raised over \$3 million to support unfunded services and client needs.

The celebration of the 40th anniversary included a brand new mural painted by Staci Ogle and NOTO artists, the addition of a "Fund A Need" tree with donations going to client needs, a community tree

that was raffled, the implementation of an online bidding system and the highest level of corporate sponsorships in the history of the Festival. The auction party was, once again, sold out and was attended by representatives from many corporations and businesses in the Topeka community, long-time supporters of SLI and volunteers who were honored for their years of service to the event and SLI, including a number of volunteers who had 30 or more years of service. The Kaw Valley Woodcarver's were honored for their commitment to the event as they have designed a tree for every Festival since its inception. In addition, Mayor and Mrs. Wolgast were our special guests for the evening.

The funds raised through Festival of Trees are crucial to ensuring the continued implementation of programs and services that are either not funded by any other means or are underfunded. Some of these programs and services include nursing, transportation, training and development, medical safeguarding and advocacy, job training for clients, dental services, medical equipment and supplies and severe underfunding in community living and community integration programs.

In order to continue to provide for services and programs and to grow and improve an event that has been enjoyed in our community for 40 years, the SLI board of directors and leadership team initiated a strategic plan specifically for the Festival to ensure its continued success and viability in the community. We are looking forward to working with our business partners to make the necessary changes over the next 3-5 years.

We have been fortunate over the years to be a part of such a supportive community and to have the backing of so many reputable and community-minded businesses in addition to hundreds of remarkable volunteers. We are genuinely grateful to all who make this event possible, in turn, making many services that otherwise would not be a feasible reality.

SLI Programs



Community Living Program

This program upports clients to be engaged in activities, volunteer in the community, learn daily living skills and other skills to increase independence. The 98 men and women living in our 21 SLI homes are provided services 24/7/365 days a year by trained SLI staff.



Independent Living Program

This program serves men and women who live in their own homes or apartments. They have learned daily living skills that allow them to live and work with a great deal of independence. Each client receives limited suports based on their needs.



Community Integration Program

In this program, focus is on life-enhancing activities, active learning and community involvement. Services are offered that reflect individual interest and support individual growth. The program is designed to assist clients to choose learning experiences, be engaged in activities, learn daily living and nutrition skills, teach responsibility and volunteer in the community.




Targeted Case Management

This program is dedicated to ensuring children and adults served are achieving their goals. Case Managers assist individuals and their families to develop and implement a person centered support plan and identify and maintain eligible state and federal funding.

SLI has access to professionals trained and educated in autism spectrum disorders and mental health and behavioral supports and planning. SLI staff has training and education in social work, psychology, human services, nursing and mental health.

Martin Family Story



Chuck Martin - 1938-2016

I would like to share just one of our many stories from a family who gave SLI the opportunity to know their loved one and care for him for over 35 years.

Charles "Chuck" Martin was born in 1938. While his father was gone from home during World War II, his family lived in Topeka with his grandparents. Even though Chuck had been diagnosed with a developmental disability,

his grandmother taught him how to read, a skill that people with his level of disability normally didn't have. He loved reading the newspaper, magazines and books throughout his life.

In the early 1980's, Chuck established his home at SLI where he remained for nearly 35 years. Over the years, he enjoyed opportunities to go to camp, go on trips, attend church and participate in social activities all sponsored by SLI.

Chuck enjoyed bird watching which was a hobby that was introduced to him by his mother and grandmother. He loved to dance, bowl, watch and listen to baseball games and Kansas Jayhawk basketball. He cared for animals and spent time volunteering at Helping Hands Humane Society. He especially loved Sunday dinners with his family. The public at large need to know they are just like all of us. They love, they laugh, and they cry. They have good days and bad days. It just may take them a little longer to express their feelings or communicate. The community needs to know that SLI is a real jewel in Topeka. We are extremely blessed by everything SLI does to provide the best possible life for people with disabilities.

SLI has always been with Chuck when he had to go to doctor appointments and on frequent occasions to the hospital. SLI provided Chuck a loving, caring environment in which to live.

At Thanksgiving, Chuck's family gathered in a circle and expressed to one another that for which they were thankful. For many years, Chuck said nothing, his voice maybe muted by a debilitating stutter. One Thanksgiving, however, he stated without the hint of stutter that he was thankful for his home at SLI.

Community Impact

FHLBank of Topeka – SLI received the Affordable Home Program (AHP) grant to cover renovations for three duplexes on Shenandoah that 30 SLI clients call home. The grant covered new flooring, countertops, interior and exterior painting, landscaping, privacy fence, new interior doors, new roofs, remodeling of two bathrooms for accessibility, new lighting, new locks and stained decks. The grant enabled SLI to update the homes and make needed accessibility changes.

Trustee – The grants received supported the implementation of the "Knowledge Is Power" staff training software program called Relias Learning which allows SLI to incorporate online learning with audio and video features for intuitive learning methods and interactive self-paced courses. The trainings will keep our staff up to date with the knowledge and skills necessary to implement creative and effective strategies for quality treatment and support for the people we serve.

Sunflower Foundation - The grant awarded will upgrade and enhance technology to support efficient operations, effective service delivery, performance management, and analysis of reports. SLI is expanding the use of technology to make improvements, eliminate redundancy and ensure accuracy of data. This is part of SLI's ongoing plan to ensure safety and efficiency for our clients and staff.


Westar Energy, FHLBank, and BNSF employees volunteered to complete projects at three SLI homes.


